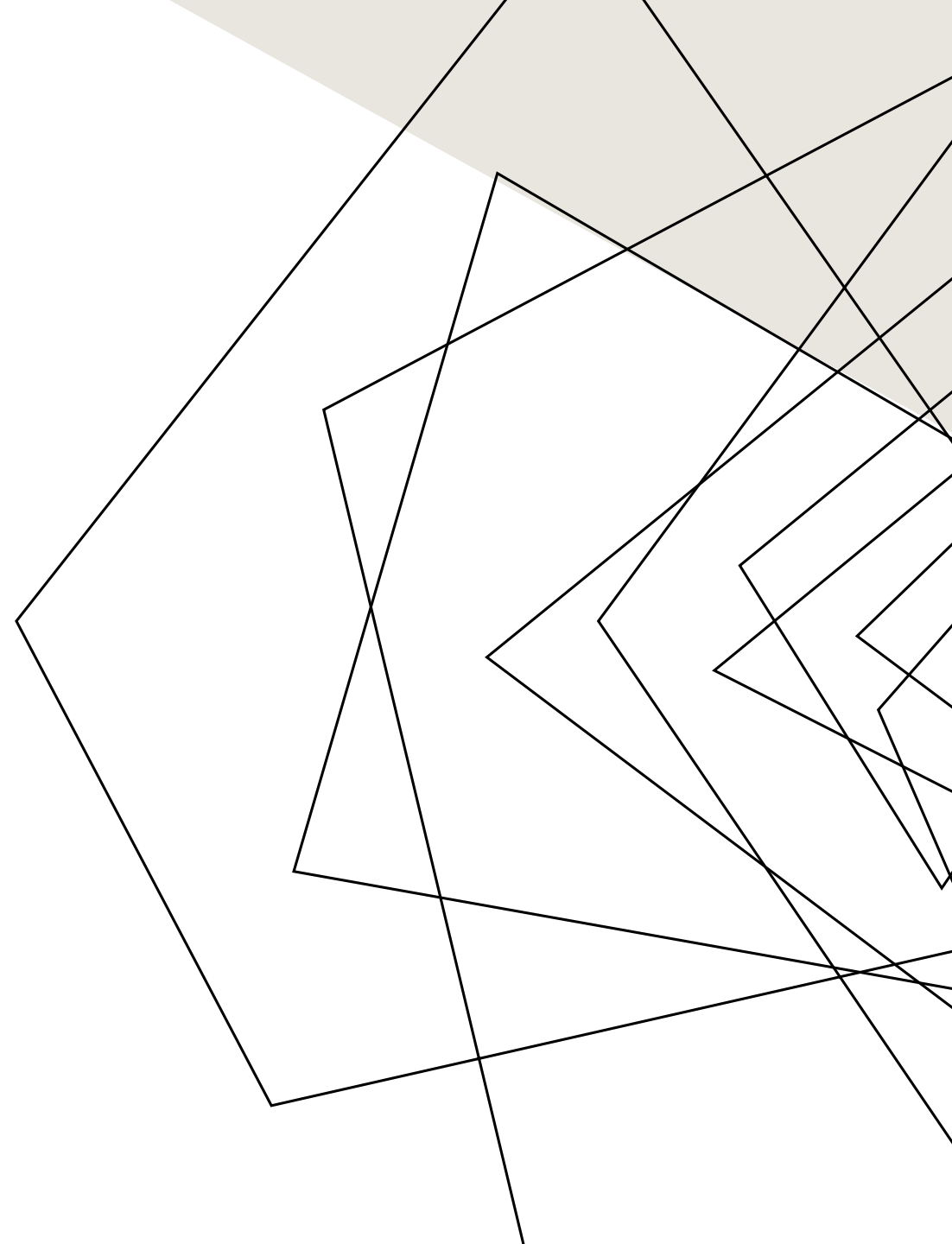

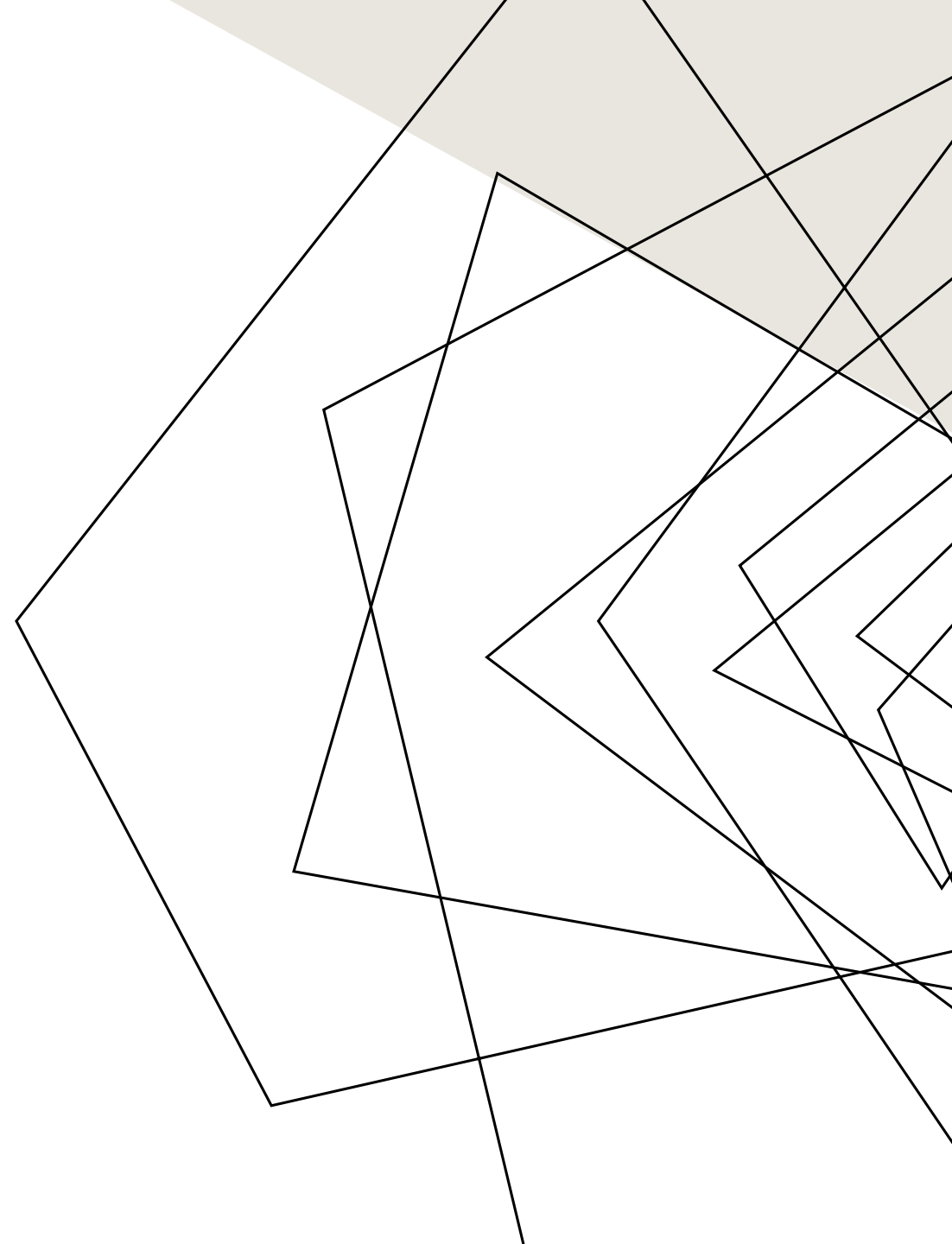

- Alignment of standard reports -



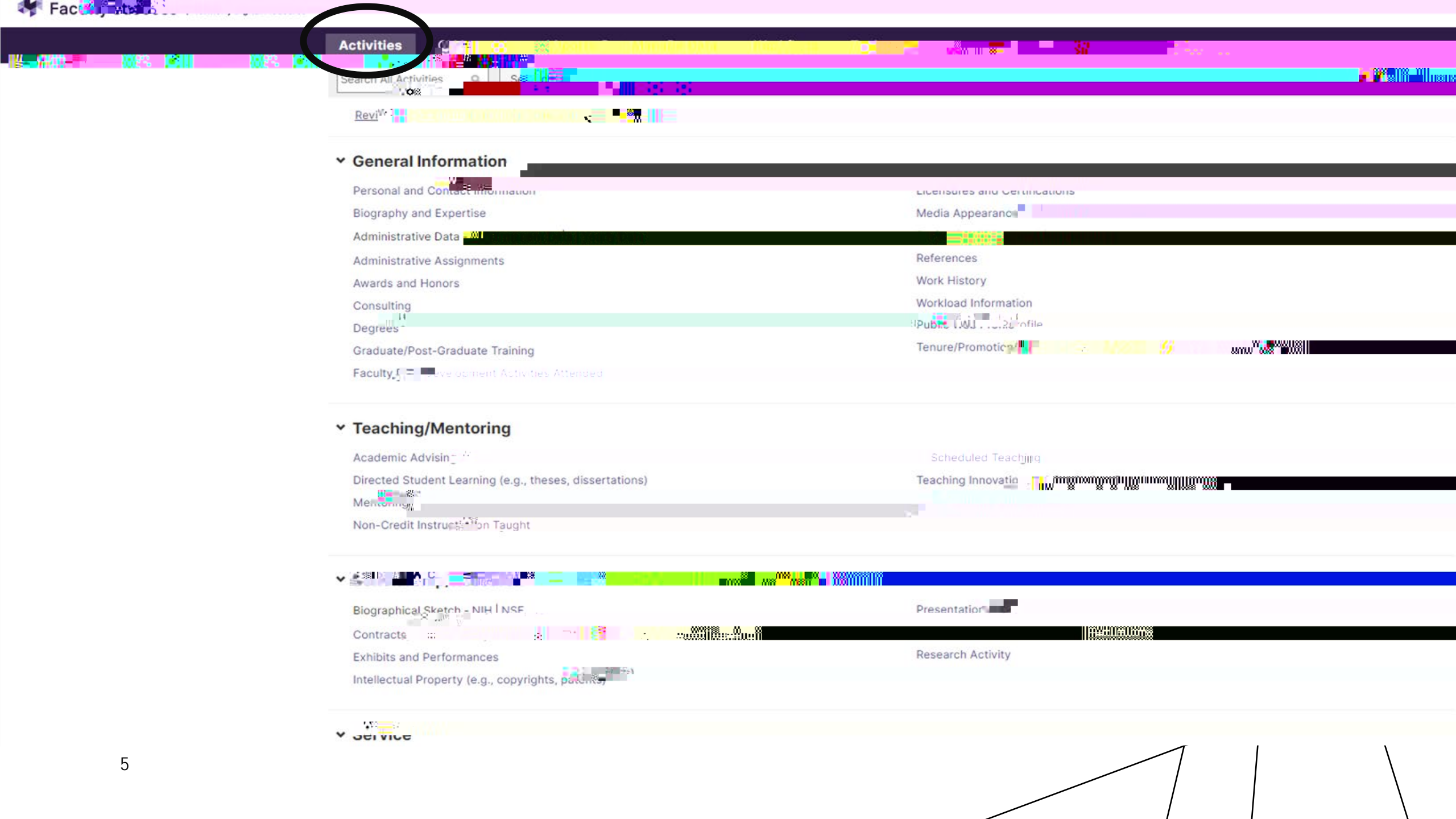
Part II:

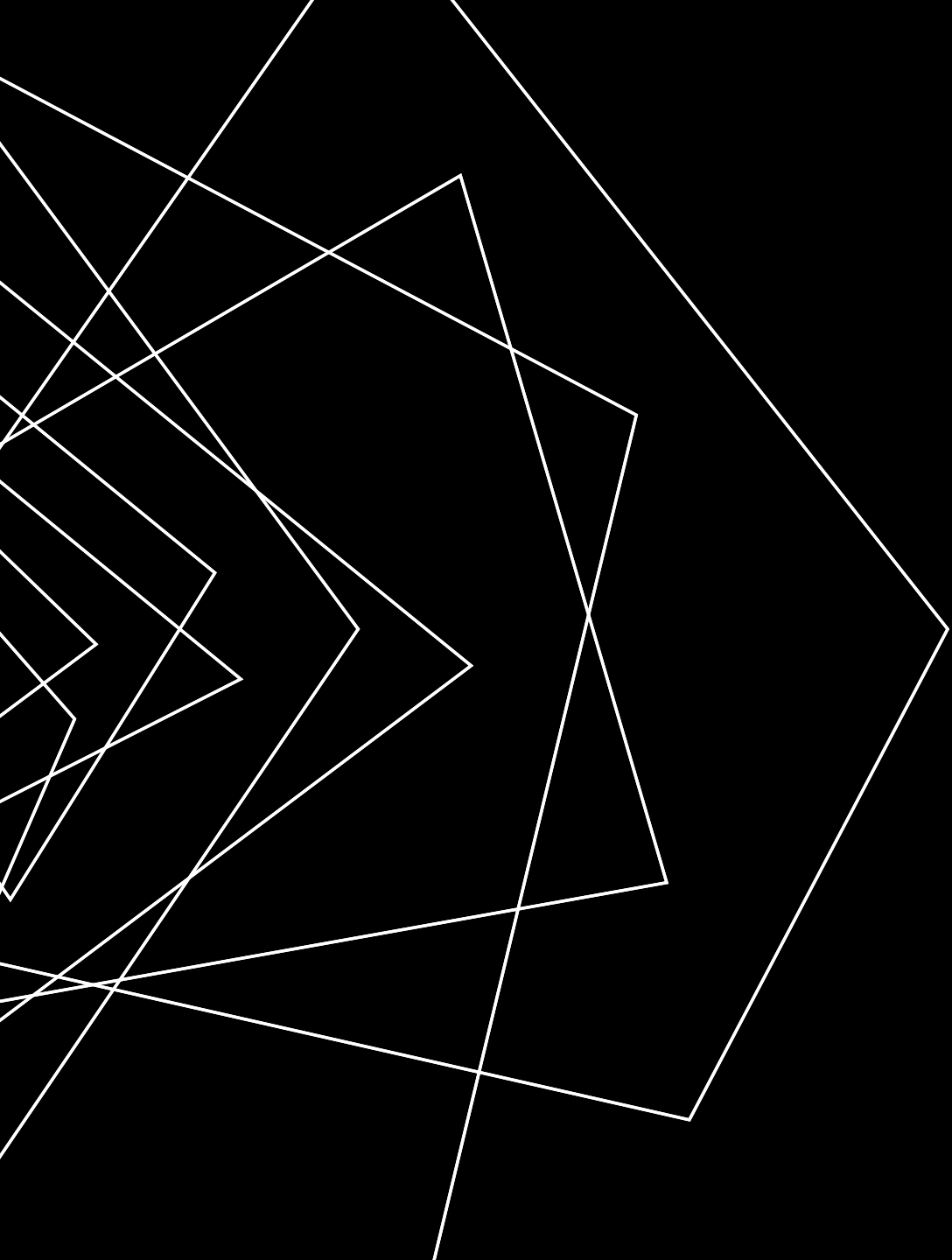
